A Better Future

Andy was angry, defiant, and acting out. He blamed mom for his dad leaving them, so he gave up on school to get back at her; he had a 0.25 Grade Point Average (GPA). Mom didn't give up on him and instead brought him to Sheridan House. The staff supported them both and Andy flourished! He graduated with a 3.83 GPA (that's an increase of 3 letter grades!) He also improved his behavior as he and his mom now communicate well and enjoy spending time together!

Our goal, as we serve single moms living in South Florida, is to give them a hand up so they can be independent women, equipped to positively contribute to society.


OUR PROGRAMS

"I want to lower/avoid capital gains on the sale of my business."


Business Gift
