That’s our mission statement at Sheridan House. We exist to help families.

One of the greatest responsibilities we have as a husband, wife and/or parent is to provide for and protect our family. Most of us do a pretty good job protecting our family, but what happens when we are not here? Who can legally make health care decisions for you if you are incapacitated? Who do you want to care for your children, your pets, and assets if the Lord takes you home early? How can you be sure your directives to these questions are executed?



There are really only three options:

- 1. The State of Florida decides through the process of probate.** Probate means the court system handles the administration of your estate (Intestate Succession). This process can take up to two years, requires legal counsel, and during that period all bank accounts and assets are frozen. That creates unnecessary hardship.
- 2. You create a Last Will and Testament (Probate is still required). Or,**
- 3. The best option is to create a Family Trust [Irrevocable or Revocable Living Trust].**

No probate needed.
